Affordable Care Act Update

At the national level, this summer has seen some activity on administrative rules implementing the Patient Protection and Affordable Care Act ("ACA"). On July 8, the IRS proposed a new rule that would expand tax credits for families purchasing pediatric dental plans under the ACA. Pediatric dental coverage is an Essential Health benefit under the ACA and may be offered as part of a comprehensive health plan or as a stand-alone benefit. In the majority of cases, pediatric dental coverage is offered separately from medical coverage as a stand-alone benefit. This separation affects the calculation of premium support tax credits available to families and individuals purchasing qualified health plans on federally facilitated exchanges. That tax credit is tied to a "benchmark" plan, the second-lowest cost silver plan in a specific region. The proposed rule would clarify the benchmark calculation to include pediatric dental regardless of whether the benefit is embedded in a medical policy or offered separately. The American Dental Association and National Association of Dental Plans have issued public statements in support of the proposed rule.

On May 13, the federal Department of Health and Human Services ("HHS") issued the Nondiscrimination in Health Programs and Activities final rule. The rule implements Section 1557 of the ACA and applies to any health care provider who receives funds through Health and Human Services, including Medicaid and CHIP. HHS has not clarified if the rule applies to dentists who only receive reimbursement under Medicare Advantage. The rule requires covered dental offices to post two notices: one of nondiscrimination and one noting the availability of language assistance services in the dental office, on the website and in publications and communications. The second notice must include taglines in multiple languages. The compliance date for the notices is October 16, 2016.

At the state level, Maine will see a new carrier, Aetna, offer plans on the state's federally facilitated exchange in nine of Maine's 16 counties for 2017. Aetna will include pediatric dental coverage in its medical plans. On June 26, Governor Paul LePage vetoed LD384, a bill to study ACA compliant options for universal health care in Maine. Maine remains the only state in the northeast not to have expanded Medicaid and has the highest uninsured rate in the northeast. To date, Governor LePage has vetoed five Medicaid expansion bills.

In New Hampshire, two dental carriers, Dentegra and Guardian Life Insurance Company, will no longer offer dental plans on the state's federally facilitated exchange after the end of 2016. Their departure will leave Delta Dental of New Hampshire and Aetna as the only carriers offering dental plans on the New Hampshire exchange.

In Vermont, the legislature has budgeted funds for an independent study to be conducted during 2016 to assess the long term sustainability of Vermont Health Connect (VHC), Vermont's state-run exchange. VHC has been plagued with technological and operational problems. The independent study will consider various options for VHC, including building on and improving the existing technology, switching to a wholly or partially federally facilitated exchange or joining with other states to form a regional exchange. The results of the study will be presented to the legislature in early 2017. On June 29, the Department of Vermont Health Access published proposed rules governing participation on VHC. Up to this point, Vermont Health Connect has operated without administrative rules, instead contracting with the providers, including Northeast Delta Dental, offering plans through the state exchange. The public comment period for the proposed rules closed on August 5.


A Note From The American Cancer Society Regarding HPV Vaccination

Vaccination for the Human Papilloma Virus (HPV) is an effective way to prevent head and neck cancers, as well as several other cancers. Unfortunately, vaccination rates are still relatively low for this cancer prevention breakthrough.

Northeast Delta Dental is partnering with the American Cancer Society to encourage dentists to deliver this important message to adolescents and their parents. The American Cancer Society recommends that all adolescents receive this vaccine beginning at age 11 or 12, but it can be given later as well.

Oral health professionals can play a key role by telling parents: "I recommend the HPV vaccine for your child in order to prevent the development of cancer later in life." A strong recommendation from a health professional has been shown to be the most effective way to increase vaccination rates.

In order to comply, all participating member dentists must successfully complete the Re-Credentialing process at least every three years to remain a participating provider.

Consultants' Corner

Radiographic and Photographic Images

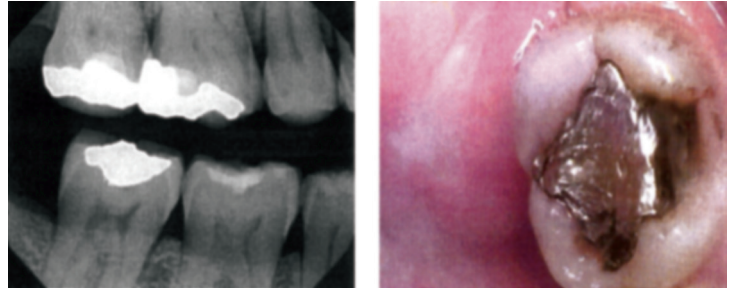
Most carriers, including Northeast Delta Dental, require radiographic images for benefit determination of certain dental procedures. Northeast Delta Dental also encourages practitioners to submit photographic images, when available, and when they will be helpful in making the benefit determination.

We recognize how helpful photographic images are for patient education, case acceptance, and documentation of oral conditions. Intraoral cameras are owned by about 50% of the dentists. They are becoming less expensive, and are of great value to the patient and dentist when making referrals, reducing risks, and overcoming any barriers to communication.

When our dentist consultants are reviewing your claim, they can make a decision only with the information that you have provided. A picture is still worth a thousand words, and it might help make the case by giving the reviewing dentist an "over the shoulder" image of what you're seeing clinically. Procedures for which photographs can be especially helpful are single crowns and core buildups (D2710 - D2794 and

D2950); soft tissue periodontal procedures and implant procedures.

An example of a case where the treating dentist submitted both a radiographic image and a photographic image for a core buildup on tooth number 3 is shown below. The criteria for approving benefits for the core build-up are not clearly evident on the radiograph, but certainly are on the photograph. Benefits for both the core buildup and crown were approved. Had the reviewing dentist had only the radiograph, the benefits might have been denied.



Six Vermont Dental Assistants Awarded Scholarships

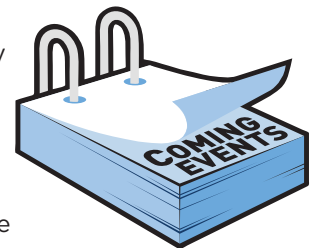

Update on Medicare and Medicare Advantage Plans

Dentists may have been seeing in trade journals the headline, "Delta Dental Kicking Out Dentists Who Don't Enroll In Medicare." **This is not true.**

Beginning February 1, 2017, all providers (including dentists) who write prescriptions or make referrals under Medicare Part D are required by the government to either: 1) enroll in Medicare; 2) Opt-In to Medicare Part D; or 3) Opt-Out of Medicare Part D.

- If a provider Opts-In to Medicare Part D, both treatment and prescriptions can be covered by Medicare Advantage plans.
- If a provider Opts-Out, prescriptions can be covered by Medicare, but treatment cannot.
- If a dentist chooses to do nothing, treatment can be covered by Medicare Advantage plans, but the prescriptions the dentist writes will be denied at the point of service.

This issue pertains to Northeast Delta Dental participating dentists who see Martin's Point Health Care patients. Martin's Point Health Care has requested that our participating dentists Opt-In to Part D. Management and Board Members will be discussing this issue further at our Board meetings in September. Rest assured, no dentist will be "kicked out" of the network.

Martin's Point will also require this of dentists outside of our operating territory as there are Martin's Point patients outside of Maine, New Hampshire, and Vermont; and, there is no national Delta Dental Plans Association requirement that other Delta Dental Member companies comport to these government requirements. We will keep you updated on this issue as more information is available.
