Important Announcements Regarding COVID-19 Relief Programs!!

In recognition of the difficulty and cost of obtaining the necessary PPE to open dental offices and begin to treat patients once again, Northeast Delta Dental implemented the following extraordinary programs.

- The \$10 per visit checks for PPE and other re-opening costs, for the month of July were issued on August 12, and distributed via U.S. Mail. So, hopefully you will have received these checks by the end of the week of August 17. These checks for July visits total \$1.4 million dollars for Northeast Delta Dental participating dentists, bringing this program's total to about \$2.5 million distributed to participating dentists in New Hampshire, Maine and Vermont. An important reminder: Because PPE and other infection control costs are considered part of the office overhead, participating providers agree not to charge Delta Dental patients a separate fee.
- For those dental offices continuing to use teledentistry, the last checks for July transmissions were issued on August 10 and mailed via U.S. Mail, so again, hopefully you will have received them by now. Teledentistry is here to stay, and Northeast Delta Dental is supportive for example, we continue to support teledentistry and fund a program to serve children at the Manchester and Concord Boys & Girls Clubs using this tool. We hope you continue to keep teledentistry in your dental office paradigm, as local laws and regulations support its use.
- The \$10 per visit checks for PPE and other re-opening costs, and the teledentistry transmission checks, with monies coming from Northeast Delta Dental's reserves, end with these July payments.
- Our Discounted Gown Program: It took a total team effort to make the initial distribution of nearly 8,000 gowns to our participating dentists a reality employee colleagues, board members, and helpful participating dentists. A huge thank you to employee colleagues Donna St. Onge, Liz Thomas, Laureen Drolet, Andy Tabor, Eleanor Vien, and LeaAnne Haney, who have helped make this happen, and for Delta Dental Plan of New Hampshire (DDPNH) Board Chair, Dr. David Staples; for having the foresight to pursue a gown supplier. It is worth noting that Dr. Staples, plus Dr. David Solomon, Delta Dental Plan of Vermont (DDPVT) Board Chair; and Delta Dental Plan of Maine (DDPME) Professional Relations Committee Chair, Dr. Jeff Doss; and former DDPVT Board Chair, Dr. Paul Averill, took a hands-on role in our PPE distribution efforts (gowns and masks). We are continuing the discounted gown program as supplies are available to us. The cost of the reusable gowns is \$40 to Northeast Delta Dental, and we are absorbing half the cost offering them to participating offices for \$20. We ask that checks be made payable to Northeast Delta Dental Foundation, so those funds will flow back into the communities for oral health projects to assist the underserved.
- We have distributed 110,000 KN95 masks for free to dental offices in Maine, New Hampshire, and Vermont, and are now in process of distributing another 5,000 on a discounted basis. The checks from dentists, similar to the checks for the discounted gown program, are made payable to the Northeast Delta Dental Foundation. In turn, those dollars, coupled with the funding received from the DDPNH, DDPME, and DDPVT corporations, are used by our Foundation to support oral health initiatives for our underserved populations via a grant process coordinated by Jennifer McGrath, Kathy Walker, and the Northeast Delta Dental Foundation Board. These payments will help substitute for the loss of Foundation funds due to the cancellation of the Dr. Carpenter Golf tournament due to COVID.
- Our N95 Mask journey was a short one. Within two days, we received orders for over 4,100 masks and exhausted our inventory. Our team is working through finalizing, shipping, and invoicing the remaining orders, so if you have not heard back from Laureen Drolet yet, she will get back to you soon. Our mutual journey through the land of PPE has been a challenging one and hopefully, the ability to acquire supplies will continue to improve. NHTI's Business Training Center Opens Dental Continuing Education for Fall 2020




